GUIDANCE AND INSTRUCTION ON ARRANGEMENTS "TO THE SATISFACTION OF THE ADMINISTRATION"

1. Purpose

This notice provides the guidance and instruction on the arrangements "TO THE SATISFACTION OF THE ADMINISTRATION" found in the International Maritime Organization (IMO) international instruments in all cases in which the Conventions are ratified by Brunei Darussalam.

2. Application

This applies to all ships registered under the flag of Brunei Darussalam and to all approved authorised organizations.

3. Procedure

3.1 The Administration will establish interpretation to provide satisfactory ways of complying with the provisions of the Conventions mentioned, the phrase, "TO THE SATISFACTION OF THE ADMINISTRATION" which shall applied exclusively to all the ships registered under the flag of Brunei Darussalam.

3.2 In cases of where there is no direct interpretation of the phrase, "TO THE SATISFACTION OF ADMINISTRATION", unified interpretations published by the International Association of Classified Societies (IACS) will be use as guidelines and in consultation with the relevant authorised organizations.

3.3 Whilst the purpose of this notice is to provide guidance or instruction on arrangements that are to be "TO THE SATISFACTION OF THE ADMINISTRATION", it is recognized that this is not appropriate to provide prescriptive guidance or instruction for all requirements due to the number of factors that have to be taken into consideration. In such cases, the technical justification for acceptance will be considered by the Administration on a 'case by case' basis; for delegated items these should be supported by the Authorised Organization in the first instance.
